A. Industry Experience

- **Industry Experience:** A minimum 5 years' working experience in the occupation that you are applying for is required for certification under the exam criteria. A minimum of two of these must be Canadian experience.
- **Homebuilding Experience:** Experience in the homebuilding sector is allowable only if the projects involve "multi-story, multi-family, poured-in-place or steel frame structures."
- **Not-for-profit:** Work for not-for-profit organizations, governments, etc., is not eligible for experience credits except in applications for Owners' Project Manager.
- Where your occupational title is not the same as the Gold Seal Designation – e.g. Project Coordinator vs. Project Manager – you must provide a job description.

B. Trade experience

If you are not certified in a trade, please provide a letter of endorsement from your current or past employer attesting to your trade experience and that you possess the skills equivalent to a certified journey person.

D. Special Industry Courses

- In order to be eligible for consideration for Gold Seal certification, seminars, workshops and courses must be essentially similar to the Gold Seal **National Curriculum Standard** of 11 course topics that includes:

Overview of the Construction Industry	Construction Safety
Law & Contracts for construction	Communication
Management of Human Resources	Estimating
Construction Job Site Controls	Planning/Scheduling
Project Costing Control and Accounting	Project Management
Environment	

**Note that course content should be managerial rather than technical.*

Formula to calculate SIC credits

6-hour education session (seminar or workshop) = **1 credit**

30-hour industry-related course = **5 credits**

E. Letter of Recommendation

Self-Employed: *If the applicant has been self-employed for more than 5 years, no letter is required. If under five years, a letter from a client is required.*

PROJECT LIST

Experience must be indicated in a signed and dated project list.

- For the project information requirements, please provide in your project list a list of the principal projects that you were associated with in each year as either a Project Manager, Superintendent, Estimator or Owner's – Project Manager. A sample project sheet is provided which may be used by applicants to list projects. (*Photocopy as needed.*)
- In order for the Gold Seal Review Committee to approve your industry experience, it is important that you provide a project list giving brief details of your work history; names, addresses and phone numbers of all employers; job titles and responsibilities; projects worked on including name, description, contract value, year and references.
- It is critical that you provide a clear description of the responsibilities that you have held over the years. Occupational titles alone do not provide sufficient insight.
- Only one project is required per year.
- If you list two occupations on one project – e.g. Estimator / Project Manager – you will be allocated with only 1/2 a year's credit for that project.

EXAM NO-SHOW

If an applicant has indicated that he/she will sit for an exam and fails to show up to write, they will be charged an administrative fee of \$50.00 + GST or HST where applicable. This administrative fee will be waived if the applicant notifies the CCA office in writing at least 10 days prior to the date of the exam that he/she will not be writing.

The Gold Seal Credit System

In order to qualify to write your Gold Seal exam you require a minimum of 100 'credits', allocated on the following basis:

Industry Experience: 10 credits per year (minimum 50)

Tradesperson qualification or equivalent: 20 credits if you are applying as an Estimator or Project Manager, 30 credits if you are applying as a Superintendent.

Related Management Skills:

- 1) Experience in one of the other Gold Seal certifiable occupations
5 credits per year to a maximum of 10 credits per occupation
OR
- 2) 30 credits if Gold Seal certified in one or more of the other Gold Seal certifiable occupations

Education and Training: (25 credits minimum, 50 credits maximum)

Grade 12:	5 credits
Industry-related Technician or Technology Diploma:	25 credits
Industry-related Degree:	30 credits
Industry-related Management Training:	1 credit for every six hours
